The Department of Disaster Management, Ministry of Home and Cultural Affairs, Thimphu, Bhutan has received financing from the World Bank toward the cost of the Hydromet Services and Disaster Resilience Regional Project (HSDRRP) and intends to apply part of the proceeds for consulting services.

The consulting services ("the Services") include:

• Development of Disaster Management Information System

The Department of Disaster Management now invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The short listing criteria are:

- The consulting firm should have more than 3 years of working experience in the field database management, data and software security, information and communications technology (ICT), web development and system programming/development, UI and UX design, geomatics, remote data collection and analysis, real-time data collection and analysis, programming for mobile platforms, disaster risk management, etc.
- The consulting firm should have enough capacity (including personnel) in handling similar assignment.
- The firm should demonstrated competency in conceptualization, formulation, and execution of Disaster Management Information System of similar nature as the one specified here.
- The consulting firm should have good financial standing and an average financial turnover of USD 100,000 in any one of the last 3 years

The attention of interested Consultants is drawn to Section I and IV of the World Bank's *Guidelines: Selection and Employment of Consultants under IBRD Loans and IDA Credits & Grants by World Bank Borrowers* dated January 2011 ("Consultant Guidelines"), setting forth the World Bank's policy on conflict of interest.
